Judge Information

- Drama Events: Humorous and Serious Acting (Solos and Duos), Classical Acting, Pantomime
- Speech Events: Humorous and Serious Oral Interpretation, Original Oratory, Memorized Public Address; Extemporaneous, Impromptu, and Expository Speaking
- Debate Events (subcategory of Speech): Policy Debate, Lincoln-Douglas Debate
- We will host **Judge's Clinics on Tuesday, January 24th and Wednesday, January 25th** in the high school library at **7:00 pm**. Specific directions for judges will be discussed. The clinic will last about 1-2 hours.
- **Food and beverages** will be provided for judges throughout the days of the meet!
